William John Adams, Generation 4

William John was born 2 August 1843 in Slippery Rock Township of Lawrence County, Pennsylvania. His wife, Mary Elizabeth McKean (McCain) was born 17 August 1847 in Butler County, Pennsylvania. William John and Mary were married 14 September 1866 and had ten children. William John, as did his father, Joseph, fought for the Union in the Civil War. Proud of his country, William John apparently never missed an opportunity of showing off his Union allegiance and would apparently appear in full military dress in local parades. A patriotic picture of William, then age 77, is kept in his family tree file and is shown below.

William John was a Union veteran of the Civil War, Company Battery C, and 212th Infantry, 6th Heavy Artillery Regiment. Private. Date of Service: Enlisted 2 September 1864; Mustered out on 13 June 1865 in Ethan Allen, Virginia. A marble military headstone is located at Rose Point Presbyterian Cemetery. 
Sixth Artillery. - Col., Charles Barnes; Lieut.-Col., Joseph B. Copeland; Majors, Robert H. Long, Joseph R. Kemp, Frank H. White. More men than the standard required had been recruited for the 54th artillery, the 204th of the line, and it was

therefore decided to organize the 6th artillery, which became the 212th regiment. It was mostly composed of men from the counties of Allegheny, Butler, Westmoreland, Fayette, Washington and Lawrence, who rendezvoused at Camp Reynolds, Pittsburg, and was mustered into the U. S. service during the first half of Sept., 1864, for one year. On Sept. 17 the regiment left for Washington, where it was assigned to the 2nd brigade of DeRussy's division, then garrisoning the defenses of the capital. On the 29th it was detached, to perform railroad guard duty on the Orange & Alexandria railroad between Alexandria and Manassas, with headquarters at Fairfax Court House. It was engaged in this service until about the middle of November when it returned to the defenses of Washington. Thus far it had served as infantry, but the men were now drilled as artillery and soon became proficient in this arm of the service. It remained in the forts about Washington until June 13, 1865, when it was mustered out at Fort Ethan Allen, returned to Camp Reynolds, where the men were finally paid and discharged on the 17th.

Battles Fought

Oral history suggests that William may have been a bodyguard for President Lincoln during the Civil War. Lincoln allegedly willed land to William John just outside of Pittsburgh. William allegedly sold the land for \$800.00 according to unsubstantiated notes from Caryl Glasser, wife of Roy Dean Glasser in **1999**. However, this information has never been authenticated.



Mary apparently used the spelling “McCain” for her maiden name but a reason has not determined as to why. It is believed that Mary’s mother was American Chippewa Indian; however, this also has not been verified. Census records of 1850 show a Mary Elizabeth McKean, age three, and her brother, James, age six, and match both of their gravestone’s birthdates. (See page 172). Mary’s father, Robert McKean, is listed but no mother is shown. Two sisters, Nancy (1848) and Amanda, (1850) are also shown in this census record.

Many cherished photographs were provided to me by Virginia Lee Scott, of Santa Barbara, California, a daughter of Alice Hazel Adams and Charles Harvey Adams, and grand-daughter of William John.



Charles Harvey Adams is the tall, handsome son standing in the background in the above photograph and is also shown here with his wife, Mary Newsome. While Charles appears to tower over his family members, his adult height was only 5'-8 1/2". (See Part 8.)

One of the many treasures I have received in my genealogical work is the above photograph of William John and Mary with their family of ten children. This photograph was given to me by my uncle Eugene Tunney Adams at a family reunion in 1993 at the Moraine State Park, north of Pittsburgh in Lawrence County, Pennsylvania. The above photograph was taken about 1890, likely in Rose Point, Lawrence County, Pennsylvania, where William and Mary lived. The names of the family and their ages are given based upon the presumption that the photograph was indeed taken in 1890.

William John was a demonstratively proud American, small in stature at 5' - 6", dark eyes likely from his mother, fair hair and complexion. He farmed and worked in coal mines and factories most of his life. (See Pension Application, pages 184-185). William John was born in Centre Township of Butler County and stayed there until he left to fight for the Union during the Civil

War. After his discharge at Ethan Allen, Virginia, on 13 June 1865, he returned home to wed Mary Elizabeth McKean in 1866 and remained in Rosepoint, Lawrence County, PA until 1890.

William and Mary were living in Beaver Falls, Beaver County, Pennsylvania when Mary passed away. Mary died of blood poisoning on 13 June 1899. She was 52 years old. Mary's tombstone reads:

" I am weary, let me rest."

Mary's tombstone was replaced by gracious persons unknown in the 1980's and maintains the same inscriptions as the original.



Death Certification for Mary Elizabeth McKean Adams

The name is spelled incorrectly; however, this document is otherwise factually accurate. This document also affirms her birth date of 1847 given she was 52 at the date of her death in 1899.

William John would have been 56 years of age when his wife, Mary, passed away in 1899.

Mary, wife of William J. Adams of Slipperyrock township, a notice of whose illness with paralysis, appeared in The News a few days ago, died on Tuesday evening aged about 60 years. Her husband, four sons and four daughters survive her and are well known in the county. Mrs. Adams was a very estimable woman and a consistent member of the Reformed Presbyterian church. The family have the sympathy of all the vicinity in this their sad bereavement. The funeral occurred at Rose Point, Rev. J. S. Martin conducting the services on Thursday afternoon. Mary's brother, James McKean, (1844-1914) also a Civil War Veteran, is also buried adjacent to Mary Elizabeth McKean Adams in the Rose Point Presbyterian Church Cemetery, Lawrence Co., Pennsylvania.

Sarah (Sade) Augusta Adams, daughter of William John and Mary Elizabeth, married Edward Flagg Mellen, Sr. and is the author of the above handwritten note. What is meant by “a hard row to hoe” is left only to one’s imagination. Pioneer women with ten children must all have faced many challenges and hardships.

Military records for William John (See Ref: Declaration for Pension, Sheet 2, page 171-172), signed by W.J. Adams on 01 October 1925) show that he remarried in 1907, eight years after Mary died. We believe the name of his second wife was Nancy Kane, and William’s military records indicate that she (his second wife) died in 1914. I also surmise that in his later years William John "married" Nancy Kane principally to allow his pension to care for her and her three children, Garnett, Olive and Bernard, who, in the 1910 census had all shown the last name of Adams. I would speculate that Nancy was essentially a caretaker to William John and was not a "wife" to him in a literal sense. Note also that the name of William’s "wife" is shown to be “Mary E.” and not “Nancy”. It is speculative as to why the actual name of his listed wife, Nancy, is not shown. Perhaps this was a memory lapse?

The above military reference indeed shows that William John (age 83) stated “*Married Sep’t 14, 1866, wife (Mary) died June 4, 1900. 1907 remarried, wife died 1914.*”

Apparently William John never formally adopted Nancy’s three children. Nancy was apparently ill when they "married" and died four years later in 1914. No mention was made of the disposition of Nancy’s three children. A census search of Nancy’s children, Garnett, Olive and Bernard indicate that they later carried the name, Kane, rather than Adams. Follow-up research on the children of Nancy Kane has not resulted in any meaningful results. It is not known whether Nancy's children received pension benefits from William John Adams' Civil War service. No such records were received in my request from the War Department's Declaration for Pension requests for William John Adams.

In 1902 William John Adams and his children, Ambrose and Amanda, were living at 2711 5th Ave, College Hill. College Hill is a neighborhood located in the northern section of Beaver Falls, Pennsylvania. Geneva College is located in the community, and is the namesake of College Hill.

Geneva College was founded in Northwood, Ohio in 1848, but it moved to northern Beaver County in 1880 after being offered free land by the Harmony Society, which was apparently highly influential in Beaver Falls. After the college was established on land just north of Beaver Falls, a community grew up around it, and in 1892, it was incorporated as the borough of College Hill. In 1932, forty years after its incorporation, it merged with Beaver Falls. As of the 1900 census, College Hill had a population of about 900. In recent decades, College Hill has become less of an industrial community than previously; the owner of the former Armstrong Cork factory donated the property to the college, which has since built an athletic complex on the site.

A number of our family members have attended Geneva College.












**William John Adams Gravestone at Rosepoint taken in 1980

That he also served Emergency Service State of Pa for 90 days under Order of Andrew H. Johnston (Here give a complete statement of all other military or naval service, if any, at whatever time rendered.)

That otherwise than herein stated he was not employed in the United States military or naval service.

That his personal description at time of first enlistment was as follows: Height 5 feet 6 inches; complexion Fair color of eyes Dark; color of hair Fair; that his occupation was Laborer

That since leaving the service he has resided at Rose Point Lawrence Co Pa until 40 years ago & came to Beaver Falls Pa since then and his occupation has been Mining and Factory work

That he requires the regular personal aid and attendance of another person and has required such aid and attendance since July 1925 on account of the following disabilities:

Cannot walk without help as my head seems dizzy and I fall some times and had an attendant since July to help me get about - (State in this space the nature of any and all disabilities)

That he not serve in the Army, Navy, Marine Corps, or Coast Guard of the United States between April 6, 1917, and July 2, 1921, or at any time during said period.

That no member of his family served in the Army, Navy, Marine Corps, or Coast Guard of the United States between April 6, 1917, and July 2, 1921, or at any time during said period

Section 2 reads as follows: That every person who served ninety days or more in the Army, Navy, or Marine Corps of the United States during the Civil War, and who has been honorably discharged therefrom, or who having so served less than ninety days, was during the war with Mexico, or on the coast or frontier thereof, or on route thereto, and every person who served sixty days or more in the War with Mexico, or on the coast or frontier thereof, or on route thereto, and every person who served sixty days or more in the War with Mexico, or on the coast or frontier thereof, or on route thereto, and every person who served sixty days or more in the War with Mexico, or on the coast or frontier thereof, or on route thereto, shall be entitled to and shall be paid a pension at the rate of \$72 per month.

INSTRUCTIONS

If the applicant claims that, by reason of age and physical or mental disabilities, he is helpless or blind, or so nearly helpless or blind as to require the regular personal aid and attendance of another person, he should file with his application a sworn statement of the attending or family physician, describing the disabilities which require the regular personal aid and attendance of another person, and giving the date from which such aid and attendance has been required; or, if the claimant is unable to procure such statement—

The sworn statement of the attending or family physician, describing the disabilities which require the regular personal aid and attendance of another person, and giving the date from which such aid and attendance has been required; or, if the claimant is unable to procure such statement—

from that date whether the claimant is confined to his house or to his bed and, if so, whether for the whole or only a portion of the time; and the relationship existing between the attendant and the claimant.

READ CAREFULLY

This form is only to be used by or in behalf of one who desires to claim original pension under the act of May 1, 1920, or because the declaration and testimony must be executed before some officer authorized to administer oaths for general purposes.

Under the law, a person may not receive pension from the Bureau of Pensions and Compensation or vocational training pay through the United States Veterans Bureau, covering the same period of time, except that the receipt of compensation by a widow or parent on account of the death of any person will not bar the payment of pension on account of the death of any other person. That part of the declaration referring to service between April 9, 1817, and July 2, 1821, should show whether the claimant or any member of his family rendered any service in the Army, Navy, Marine Corps, or Coast Guard of the United States during said period, and if so, the full name under which such service was rendered, together with the designation of the organization in which such service was rendered, with date of entrance and discharge.

The term "family" includes: Child, legally adopted child, stepchild, father, mother, stepmother, stepfather, father and mother through adoption, and person who has stood in place of parent for a period of not less than one year prior to induction into service.

Compliance with these instructions will expedite the adjudication of the claim.
